Your Dog and The Law: Town of Oakville By-Law #2018-006

- Dog Excrement: The owner/keeper of a dog shall immediately remove its excrement from public or private property
- Running at Large: Dogs are not permitted to run at large in the Town of Oakville, exceptions are within a designated "Leash free zone" and the owner/keeper has accompanied the dog
- Leash Law: Dogs must be on leash at all times, unless on owner's property or a designated "Leash free zone".
- Number of Dogs: No person shall keep at any one time or any one place more than three (3) dogs of an age in excess of six (6) months
- **Dog Licencing:** Dogs must be licensed within 7 days of residency and have the issued licence securely attached to the dog at all times. Licences shall be good for one year from date of issuance and must be renewed annually before expiration.
- Biting Dogs Any dog that bites or attacks a person or domestic animal may be declared a biting or potentially dangerous dog
- Barking Dogs (Town of Oakville By-Law Bylaw #2009-081); Barking that disturbs the peace and quiet of any individual is
 monitored by the Town of Oakville. Complaints must be made to the Bylaw Enforcement Department directly at 905-845-6601

All notifications of renewal are a courtesy only. Failure to receive notification does not exempt any dog owner from their legal requirement to maintain a valid licence.
